Approve minutes of meeting held December 15, 2010.

Upon a motion duly made by Director Wynn and being seconded by Director Fricke, the Board voted unanimously to approve the minutes of the meeting held December 15, 2010.

Receive public comment.

Mr. David Hawes reviewed the protocol and procedures for public comments. He explained that the Board receives comments from the public only during this part of the agenda. He said that those who wish to speak should please register on the Public Comment Sign-In sheet near the meeting entrance. Remarks are limited two minutes. Pursuant to the Texas Open Meetings Act, the Board may not deliberate or make any decision about an issue that does not appear on its published meeting agenda. The Board has four options for dealing with any non-posted issue brought before it:

- Respond with a statement of specific factual information or recite the existing policy on the issue
- Direct you to visit a staff member about the issue
- Place the issue on the agenda of a future meeting
- Post the matter as an emergency if it meets the criteria for an emergency

There were no public comments.

Present Certificates of Appreciation to Officers John Obenhaus and Leon Laureano for their outstanding work in assisting in the apprehension of a serial burglar.

Director Nagar, chair of the Public Safety and Security Committee, addressed the Board and the public. He presented awards certificates to Officers Obenhaus and Laureano, who recently apprehended a suspect believed to be responsible for 150 area burglaries. He explained that the District funds extra security patrols several times each week in the area, including rotating evening and daytime shifts. He gave a brief overview of the success of the security patrols since March, 2010, including the following accomplishments:

- 26 felony arrests
- 88 misdemeanor arrests
- 42 traffic tickets
- 275 parking tickets
- 12 felony warrants
- 22 misdemeanor warrants
- 109 criminals jailed
